Section I. INSTRUCTIONS

Appointed officers (any person appointed to any statutory office or position of employment, including members of city boards and commissions), elected officers, and employees of Draper City are required to comply with the provisions and requirements outlined in Title 19, Chapter 2 of the Draper City Municipal Code, *Disclosure, Conflicts of Financial Interest*, and Title 10, Ch. 3, Part 13 of the Utah State Code, *Municipal Officers' and Employees' Ethics Act*.

Appointed officers, elected officers and employees are also required to complete this form within thirty (30) days of being appointed, elected, reelected, or beginning employment, and again if either (i) the Discloser's position with the City has changed, or (ii) if there has been any significant change in the value or ownership interest in any covered business interest or any transaction involving the City.

1. Disclosure of Interest in Business Entity Doing Business with Draper City. If you are an owner of a substantial interest in any business which does or anticipates doing business with Draper City, you need to make a public disclosure of the same.

"Substantial interest" means the ownership, either legally or equitably, by an individual, the individual's spouse, or the individual's minor children, of at least 10% of the outstanding shares of a corporation or 10% interest in any other business entity.

I acknowledge my obligation to publicly disclose the nature of my interest in the business entity to the members of a body (i.e. council, commission or committee) prior to any discussion by that body of matters related to the business entity. City employees should disclose to the City Manager.

2. Disclosure of Investment Creating a Conflict of Interest with Duties: Appointed officers, elected officers and city employees cannot have personal interests or investments that create a conflict between personal interests and public duties. City employees should disclose to the City Manager.

I acknowledge my obligation to publicly disclose any personal interest or investment which creates a conflict of interest with my public duties in an open

meeting to the members of a city body (i.e. council, commission or committee).

C. Disclosure of Transactions Involving the City:

No appointed officer, elected officer or employee shall receive or agree to receive compensation from anyone other than the City for assisting any person or business entity in any transaction involving the City, unless he or she files a sworn written statement. If this is applicable to you, provide the following information. Otherwise, read and acknowledge the bolded information at the end of this Section C:

An elected officer, or an appointed officer who is a member of a public body must also make an oral disclosure of the information in Section II. C to other members of the public body immediately before the discussion regarding the business entity being assisted.

An appointed officer or employee who is not a member of a public body must also disclose the information in Section II. C to their immediate supervisor and other city officers and employees who may rely upon the appointed officer or

employee's representations in evaluating or approving a transaction.

The obligation to disclose is ongoing. The written disclosure must be filed 10 days before any agreement is entered into, or 10 days before receipt of compensation, whichever is earlier.


