Section I. INSTRUCTIONS

Appointed officers (any person appointed to any statutory office or position of employment, including members of city boards and commissions), elected officers, and employees of Draper City are required to comply with the provisions and requirements outlined in Title 19, Chapter 2 of the Draper City Municipal Code, *Disclosure, Conflicts of Financial Interest*, and Title 10, Ch. 3, Part 13 of the Utah State Code, *Municipal Officers' and Employees' Ethics Act*.

2. Disclosure of Investment Creating a Conflict of Interest with Duties: Appointed officers, elected officers and city employees cannot have personal interests or investments that create a conflict between personal interests and public duties. City employees should disclose to the City Manager.

C. Disclosure of Transactions Involving the City:

No appointed officer, elected officer or employee shall receive or agree to receive compensation from anyone other than the City for assisting any person or business entity in any transaction involving the City, unless he or she files a sworn written statement. The obligation to disclose is ongoing. The written disclosure must be filed 10 days before any agreement is entered into, or 10 days before receipt of compensation, whichever is earlier.
